

The 16th China Hardware Products International Industrial Design Competition

ENTRY INSTRUCTIONS

I. ENTRY RULES

1. A contestant can deliver multiple entries to each categories of competition at the same time.
2. Format of the entry: JPG file, A2 (420mm*594mm), 300dpi, **VERTICAL VERSION, NO MORE THAN 5M. ONE ENTRY IS LIMITED TO ONE LAYOUT.**
3. The entry layout is composed by the following contents: category of competition, more than two main views of the product, design instruction, title of the entry (there should be NO name of participants in the entry layout).
4. The entries must be sent along with the application form : [《Entry Form》](#) , by email to: design@ykwjdesign.com.
5. Once submitted, the entries and information cannot be modified.

II. INTELLECTUAL PROPERTY

1. Entries must be original works of the participant (not to infringe other people's intellectual property rights or any other rights). Entries must be created specifically for this competition.
2. The intellectual property rights of Golden, Silver, Bronze, Excellence Prize of the competition, belong to the sponsoring enterprise and the competition organizing committee. The sponsoring enterprise has the right to declare the patent of the winning works before the works are exhibited. The author of the design has the right to co-sign the patent. If the entries are industrialized, the design authors will be given certain economic rewards according to the specific circumstances. Participants are not allowed to apply for or transfer the intellectual property rights of the winning works without the permission of the organizing committee.
3. The competition organizing committee has the right to display, publish and publicize all entries. Without the permission of the organizing committee, no other unit or individual may publicize, publish, display, etc., the design plan of the award-winning products of this competition.
4. The legal liability caused by the plagiarism works and the theft of trade secrets by contestant shall be borne by the contestant. The organizer has the right to disqualify the contestant.
5. In case of violation of the above terms and serious consequences, the competition organizing committee reserves the right to pursue the legal responsibility of the corresponding responsible person. Disputes arising from the implementation of this entry instructions shall be under the jurisdiction of the court where the committee is located.
6. The competition organizing committee reserves the right of final interpretation of this competition.

III. AWARD NOTIFICATION, CERTIFICATES AND BONUSES

1. Important notices such as the evaluation results, award notification, etc., will be released through the official website:

<http://www.ykwidesign.com>. Participants are requested to pay close attention to the official website, so as not to miss important information.

2. Prize money will be wire transferred after award ceremony in accordance with the national tax provisions and processes in the current year.
3. Prize money will be transferred to the nominated personal account or the company (including the branch company) account. Domestic recipient can be a company or individual, while foreign recipient can only be an individual. If the recipient is not the system registrant, a written authorization is required.

IV. PARTICIPANTS SHALL BE DEEMED TO AGREE ABOVE TERMS ONCE SUBMITTING THE ENTRY. THE COMPETITION ORGANIZING COMMITTEE RESERVES THE RIGHT OF FINAL INTERPRETATION.
